The legal voters of the Town of Irasburg are hereby notified to meet at the Town Hall in Irasburg Village on Tuesday, the 2<sup>nd</sup> day of March, 2009, at 7:00 pm in the evening to transact the following business.

1. To elect a moderator for the ensuing year.
2. To elect a Town Clerk for a term of one year
3. To receive and accept the auditors' report
4. To elect all other officers by law to be elected at annual meeting:
  - Treasurer for a one year term
  - Selectmen for a three year term
  - Lister for a one year term
  - First Constable for a one year term
  - Delinquent Tax Collector for a one year term
  - Auditor for a three year term
  - Grand Juror for a one year term
  - Town Agent for a one year term
  - Library Trustee for a three year term
  - Trustee of Public Money for a one year term
5. To see if the Town will vote to raise money to pay current and incidental charges against the Town for the ensuing year.
6. To see if the Town will raise money to maintain the roads within the Town.
7. What shall the Town do to raise funds for the replacement of road equipment?
8. To see if the Town will vote to collect property taxes with a due date of October 31<sup>st</sup>, without penalties. After due date the taxes shall be placed in the delinquent tax collector's hands with added 8% penalty and interest.
9. To see what sum of money the Town will vote to raise for the maintenance and support of the Town Hall.
10. To see if the Town will raise \$11,000.00 for the replacement of the Town Hall upstairs windows.
11. To see what sum of money the Town will raise for the maintenance and support of the Leach Public Library.

12. To see what sum of money the Town will raise for the maintenance and support of the Fire Department.
13. To see if the Town will raise \$29,297.00 for the Engine #1 body replacement.
14. To see if the Town will vote to raise \$10,138.30 For the Orleans County Sheriff's Department.
15. To see if the Town will appropriate a total of \$9,790.50 to the individual agencies and services listed below, in separate amounts specified for each and by taxes to be assessed by the Selectboard:
